SUBJECT: Tintwistle Community Centre

PURPOSE: To seek confirmation of the actions to be taken following consultations on Public Work loan funding for a new Tintwistle Community Centre

RECOMMENDATIONS: That Tintwistle Parish Council (TPC) considers the proposals and makes any revisions prior to further planning decisions

1. Background

At the Tintwistle Community Centre Committee meeting on 14 March 2023, it was agreed to pursue a Public Works Fund Loan application based on increasing the TPC precept. On 26 June 2023 the Parish Council approved the proposals for the consultation process with a special newsletter in July which explained the Public Works Loans Board (PWLB) process and a voting form setting out the 2 key PWLB questions. 9 sessions were publicised. The questions and comments have been recorded along with emails received. Voting forms have been collected. Completed SurveyMonkey forms, advised by PWLB, are being received. The Clerk is working an 3 extra hours per week until the 30 August to handle the additional work involved.

2. Options for Council

- i. Approve the proposals for actions following the consultations
- ii. Approve the proposals with amendments
- iii. Reject the proposals with the implication that the Committee draws up fresh proposals

3. Reasons for Recommendation

It is best practice to consider fully the outcomes of any community consultation process, to properly acknowledge feedback and take it into account in future planning decisions

Expected Benefits

The Parish of Tintwistle and Crowden will benefit in the following ways:

- Residents are effectively informed on future TPC plans for a new Community Centre
