## View from the Chair

In the last couple of months, we have had successful local events where residents have had a chance to demonstrate their extraordinary creative skills and imagination - the Scarecrow Competition, the Flower Competitions and the Tintwistle Allotments and Gardeners' Association Village Show, where handicrafts are a popular section. Where do people get their ideas from and turn them into something beautiful, interesting - and useful??! As a one-time teacher, I was taught that there are different kinds of intelligence which we all have to a greater or lesser extent - and one of which is creativity. grateful to all of you who have contributed your views so far during the Community Centre consultation period. Many of you have suggested new ideas and different ways of approaching this challenge. The outcome may not be what anyone first envisaged but, if it goes towards meeting your needs and those of generations to come, that is a solution to a problem -to which all our imaginations and creativity will have contributed.

### Remembrance Sunday 12 November 2023

Every year the Parish, along with the rest of the country, commemorates those service people who were lost in the two world wars and other conflicts. Remembrance Sunday takes place every year on the second Sunday in November. Since 1921 residents of Tintwistle and Crowden walk from Conduit Street up Old Road to the Cenotaph led by

the brass band. You are invited to gather at 10.30am on Conduit Street. Everyone is welcome. There will be a short service led by the United Reformed Church followed by the two minutes silence. One by one representatives of local organisations and businesses lay their wreaths on the War Memorial. For many years the British Legion have provided the wreaths which have been ordered through Dorothy Crutchley in Hollingworth. This will be Dorothy's final year of carrying out this valuable service to the community. Next year a new arrangement will need to be organised. Meanwhile if you have ordered a wreath this year it will be available for collection from the Conservative Club the week before.

## COMMUNITY CENTRE UPDATE

In July the Parish Council issued a Special Newsletter that focused on planning for a new Community Centre. With advice from the Derbyshire Association for Local Councils (DALC), the Council chose, in the absence of any other funding opportunity, to apply for a Public Works Loan. This is a government fund which requires a local authority to calculate the contribution of Band D taxpayers to pay back the loan. The PWLB needs the Parish Council to ask 2 key questions - whether an individual would like a new Community Centre (located on the old site) and if so, what time period the Council should apply to the payment of the loan -15, 25or 50 years. PWLB instructs the Council to issue voting forms to all residents. Residents have been returning the forms, though unfortunately some were flawed. To date a total of 9 consultation meetings have been held and a total of 74 people attended, some coming to more than one session, roughly 2% of the population of Tintwistle and Crowden. In addition, the Parish Council has received questions and comments from over 30 people.

At the Parish Council meeting on 16 September, it was resolved to extend the consultation period to 22 October to enable more people to contribute their views and ideas.

There is a concern that the consultation process has not been as inclusive as it could be. Not everyone wants to or can come to a public consultation meeting so we are looking for other ways in which we can make sure we reach you and listen to your views. The Council has approached public venues in Tintwistle to arrange to hold drop -in sessions on their sites. The Clerk and Councillors welcome comments and questions from anyone who has not responded so far, in writing, by email or in person. The dates and times will be publicised shortly. Please look out for posters, on Facebook pages and the Parish Council website for further information. Because the consultation period is being extended the final outcomes will be published in a November newsletter.

Meanwhile, the Parish Council is working on several fact sheets in response to questions that have been raised in the consultation sessions: the role of the Parish Council and Councillors; the PWLB requirements and costings; a timeline of planning decisions made on the Community Centre; the story of the Bowling Club and information on the plans for the new building, what it will be used for and why.

Several other events have occurred which are further shaping decisions about plans for a new Community Centre. The Tintwistle Cricket Club has submitted a proposal to develop the Cricket Club pavilion as a 'community hub'. This proposal has been formally presented to the Tintwistle Community Centre Committee and full Council. Discussions are underway. The proposal can be viewed on the Council website and is available on paper from the Clerk. Secondly, there is a government funding stream, the Community Ownership Fund, which has been opened up to Parish Councils. The Parish Council is submitting an Expression of Interest. This funding does not require a taxpayer contribution. Thirdly, the Council has agreed to a structural audit of the 'green hut' which will be carried out in the next few weeks. This will determine how long this building can be used before it must be closed for use and demolished.

### **MEMORIAL STONE ~ MISSING**

Dotted around many reservoirs on hillsides, small shanty towns had sprung up to accommodate the navvies and their families. Houses, built of piled stones and mud, were thatched with ling from the moors, and many used potato sacks as doors.

A tragic incident concerning one family was reported in the Manchester Guardian on Saturday 26 August 1854:

Sad death of two children. On Monday afternoon last, an inquest was held before Mr C Hudson at the Black Bull, Tintwistle, on the remains of Joseph Forshaw, aged two years and Robert Forshaw, aged four years, the children of James and Ann Forshaw, who resided in a hut near the first milestone from Tintwistle, on the Woodhead Road, no other habitations being nearer than 400 yards. The hut in question was only one storey high, and was built of rough stones and clay, and covered with straw thatch. It had two rooms, in one of which there were beds for six lodgers, and in the other there was sleeping accommodation for the father, mother and three children. The mother's statement was to the effect, that she generally arose at 4am in the morning, in order that her husband, who was a sub -contractor under Mr Taylor, at the Arnfield Reservoir, and the lodgers, might go to their work

#### in due time.

The children generally arose with her, and after her other boy had gone to his work at the mill, she made a practice of going to bed again with the children for about an hour. She had done so on the previous Friday morning, and after rising a second time, she milked a cow and occupied herself with other work until between nine and ten o'clock. She then went to weed a patch of potatoes close by the house, leaving a fire burning, and the two children asleep in a bed which stood about a yard from the fire. She had been in the potato ground for about an hour, when she bethought herself of going home to the children, but on looking at the house, she saw that it was enveloped in smoke. She unlocked the door and tried to go in for the children, but she was compelled to retreat, as the roof as falling in, and the place was in flames. Other Witnesses stated that they saw the fire, and went to the place, and one of them broke in through the lodgers' room, but could not render any service, as that part was on fire. The children's remains, which were found where the bed stood, were drawn from the burning ruins with a potato hoe, their bodies falling in pieces. The beds, furniture, clothes, and other contents of the house were consumed.

The jury returned a verdict of 'accidental death', stating at the time, that there had been gross neglect, which had been the cause of the accident. The children were interred in one coffin the same evening.

To remind us where the incident occurred, a marker stone was put in place, built into the stone boundary wall on the reservoir side of the road, a mile outside Tintwistle.



The marker stone is inscribed: 'Burned down. Two children burnt to death, aged 3 and 5 years.'

Very recently, the stone wall was severely damaged as a result of a lorry crashing into it and the stone has disappeared.

The next public meeting will be held on Saturday 11 November at the Council Offices on Sexton Street at 4pm. Everyone is welcome. Do bring along any artefacts or memorabilia that you think others would be interested in.
