TINTWISTLE PARISH COUNCIL CLIMATE CHANGE PROGRAMME 2022 – 2025 AS AT FEBRUARY 2024

1. Statement of Intention

Tintwistle Parish Council has the power and the ability to influence and enable our residents, businesses, and community organisations to reduce their carbon footprint and to contribute to meeting the UK zero carbon target by 2050.

How do we intend to do this?

- Partnership working will be central to tackling the changes we need to make – working with individuals and our 'stakeholders' eg Peak District National Park, High Peak Borough Council, United Utilities.
- We shall provide leadership by example and encourage behavioural change
- We shall work to make national and global climate change issues relevant to the local community and seek to motivate individual and collective responses to climate change challenges.

The Parish Council will address the following themes:

- 1. Eliminating energy wastage from buildings
- 2. Reducing and eliminating the burning of fossil fuels, encouraging the use of alternative heating
- 3. Reducing the number of private vehicles and encouraging and supporting the use of public transport
- 4. Encouraging the alteration of consumption patterns, buying less, and reusing and repairing more, choosing low carbon products, working with contractors who work towards carbon zero
- 5. Encouraging the increase of recycling rates
- 6. Encouraging meat free diets and reducing food waste
- 7. Adopting land management practices that reduce emissions, protect, and promote diversity
- 8. Managing green spaces to promote and increase biodiversity and soil carbon
- 9. Including climate change as an aspect of all Parish Council decisions
- 10. Showcasing local examples of good practice
